Held in the Apartments of the Geological Society, Burlington House, London, W., January 20, 1925, at 4.80 p.m.

Prof. W. W. WATTS, F.R.S., President, in the Chair.

The deaths of Sir Archibald Geikie, one of the original members of the Society; Prof. G. D. Liveing, one of the members of the Crystallological Society; and Mr. R. C. Webb were announced.

Mr. Henry Dewey, Prof. William Arthur Tarr, and Mr. Sergei Ivanovich Tomkeieff were provisionally elected Ordinary Members of the Society.

The balance-sheet and abstract of receipts and payments for the year ending December 81, 1924, were submitted and were approved subject to audit by Dr. Harwood and Mr. De Castro, who were appointed auditors. It was resolved that in future the auditors be appointed at the November meeting.

The Treasurer reported to the Council certain members whose subscriptions were in arrears; and he was instructed to take action in accordance with bye-law 7.

## GENERAL MEETING.

## Held in the Apartments of the Geological Society, Burlington House, London, W., January 20, 1925, at 5.80 p.m.

Prof. W. W. WATTS, F.R.S., President, in the Chair.

Eighteen Members and four Visitors were present.

The death of Prof. G. Murgoci, an Ordinary Member, was announced. Mr. Alpheus Fuller Williams and Mr. Ivan Sidney Double were

provisionally elected Ordinary Members of the Society. It was decided to publish an index to vol. 2 of the Abstracts for the three years 1928-5 in the same form as the index to vol. 1, with a similar topographical index; and also an index to vols. 11-20 of the Journal for the thirty-one years 1895-1925.

The future of the Library of the Society was discussed, and a committee consisting of the Librarian (Prof. Lewis), Dr. Hutchinson, Dr. Prior, Mr. Campbell Smith, and Dr. Spencer was appointed to consider the matter and to report.

## Held in the Apartments of the Geological Society, Burlington House, London, W., June 16, 1925, at 4.30 p.m.

Prof. W. W. WATTS, F.R.S., President, in the Chair.

The following were provisionally elected Ordinary Members of the Society: Dr. Robert Campbell, Dr. Hardy Vincent Ellsworth, Mr. Aubrey Evelyn Horn, Mr. Robert Angus Alister Johnston, Dr. James Malcolm Maclaren, Dr. Patrick Marshall, Mr. William Elgin Swinton, and Prof. Ellis Thomson.

The following changes in the list of Officers and Council were approved for recommendation to the Members of the Society: Vice-President-Sir Thomas Holland in place of Dr. H. H. Thomas; Ordinary Members of Council—Prof. P. G. H. Boswell, Mr. T. Crook, Mr. L. Hawkes, and Dr. H. H. Thomas, in place of the four retiring Members of Council, Dr. Brammall, Mr. De Castro, Mr. Edge, and Sir Thomas Holland.

It was decided to hold four meetings next year on the following dates : Tuesdays, January 19, March 16, June 15, and November 2.

The Library Committee reported that a preliminary sorting had been made of books and periodicals to be retained and those to be discarded. It was proposed to keep all of purely mineralogical interest including separate copies of mineralogical papers, and also for the present all periodicals which are still being received. Of those to be discarded the Geological Society should be allowed the first selection of any which might be useful for completing sets, &c., and afterwards the Sedgwick Museum and other Libraries in Cambridge. The residue should be sold to booksellers who were to be invited to make offers for it, and the proceeds were to be devoted to the upkeep of the Library. The Committee was given power to act in accordance with these proposals.

Twenty-one Members and four Visitors were present.

Held in the Apartments of the Geological Society, Burlington House, London, W., November 3, 1925, at 4.30 p.m.

Prof. W. W. WATTS, F.R.S., President, in the Chair.

Dr. Arthur Richard Dwerryhouse, Mr. Arthur Douglas Lumb, Dr. Edmondson Spencer, Prof. Aladár Vendl, and Prof. Miklós Vendl were provisionally elected Ordinary Members of the Society.

Mr. J. P. De Castro and Mr. A. F. Hallimond were appointed Auditors of the accounts for the year ending December 31, 1925.

A letter from the Royal Society was read announcing the grant of  $\pounds 100$  from the Government Publication Fund towards the cost of publication of Mineralogical Abstracts.

#### XXVIII PROCEEDINGS OF THE MINERALOGICAL SOCIETY.

The Editor reported that the December number of the Journal was in hand and would consist of indexes to vol. 20 of the Magazine and vol. 2 of the Abstracts, for which some 15,000 slips had been written.

The Library Committee presented a detailed report with lists of periodicals, &c. that had been disposed of, these apparently containing no matter of mineralogical or crystallographical interest. Certain presentations of small broken sets had been made on behalf of the Society to the libraries of the Geological Society of London, the Sedgwick Museum of Geology at Cambridge, the Cambridge School of Geography, and the Cambridge Philosophical Society. The remainder disposed of realized a sum of £55. The next task of the Committee will be to decide how best this fund may be employed for completing gaps in the set of periodicals retained and in binding some of the more useful and important. [The Society's Library has been housed in the Mineralogical Museum at Cambridge since 1890.]

Dr. A. Hutchinson was appointed Librarian in place of Prof. Lewis.

A Committee consisting of the President, Treasurer, General Secretary, Foreign Secretary, Editor, Dr. Hutchinson, Sir Henry Miers, Mr. Campbell Smith, Dr. Herbert Smith, and Dr. Thomas was appointed to consider how the Jubilee of the Society next year should be celebrated.

## GENERAL (ANNIVERSARY) MEETING.

Held in the Apartments of the Geological Society, Burlington House, London, W., November 3, 1925, at 5.30 p.m.

Prof. W. W. WATTS, F.R.S., President, in the Chair.

Twenty-one Members and seven Visitors were present.

The Chairman nominated Messrs. Garnett and Grantham to act as scrutineers of the voting-papers for the election of Officers and Council. The elections as Ordinary Members of the Society of Dr. A. R. Dwerryhouse, Mr. A. D. Lumb, Dr. E. Spencer, Prof. Aladár Vendl, and Prof. Miklós Vendl were confirmed.

A vote of thanks to the Geological Society for permission to meet in the Apartments of the Society was carried.

The General Secretary then read the following ANNUAL REPORT OF COUNCIL.

During the Session 1924-5 four ordinary meetings have been held (by kind permission) in the Apartments of the Geological Society, Burlington House, W., at which twenty papers were read.

Four numbers of the Journal (nos. 107-110), containing twenty papers and 703 abstracts, have been issued quarterly. In no. 110 the blocks for Plates VII and VIII were lent by Dr. Hutchinson.

A Committee was appointed to consider the state of the Society's Library, and in accordance with its recommendations the books retained in the Library have been reduced to those of purely mineralogical interest including separate copies of mineralogical papers and also, for the present, all periodicals which are still being received by presentation or exchange. Of the books discarded, some were presented to the Geological Society of London, the Sedgwick Museum of Geology, the Cambridge Philosophical Society, and the Cambridge School of Geography, and the residue was sold. The proceeds of the sale are to be devoted to the upkeep of the Library.

The contributed papers and discussion of the joint meeting of the Faraday, Geological, and Mineralogical Societies on the physical chemistry of igneous rocks has been published, and is available to Members of the Society at a reduced price.

The balance-sheet for the year ending December 31, 1924, showed that the financial position of the Society was satisfactory. The assets (exclusive of the Library and stock of the publications) amounted to  $\pounds1,404$  7s.  $3\frac{1}{2}d$ , with no liabilities. The value of the Stock invested in the names of the Trustees of the Society was on that date  $\pounds1,112$  17s. 6d, corresponding to  $\pounds24$  8s. 1d. for each Life-Member. A sum of  $\pounds100$  was granted by the Royal Society from the Government Publication Fund in aid of the publication of 'Mineralogical Abstracts'.

During the Session the Society has lost by resignation two Ordinary Members, by removal for non-payment of subscriptions two Ordinary Members, and by death four, namely: Sir Archibald Geikie, one of the original members of the Society; Prof. G. D. Liveing, one of the members of the Crystallological Society;
