The following Report was read and adopted -

"The Council, on the completion of the Sixth Year of the Society's existence, has to congratulate the Members on the appearance in the last part of the Journal of a balance-sheet showing a healthy financial position.

- "The balance in the Treasurer's hands at the foot of that account was but small, £5 8s. 8d., but the statement of Assets and Liabilities shows that the debt to our printers, which stood at £230 16s. 6d. on the 81st of December, 1880, had been reduced to £94 10s. 7d. * at the corresponding date in 1881.
- "This old debt has now (July, 1882) been completely cleared off, and the only accounts outstanding are for printing and illustrations of the numbers of the Journal issued in the course of the year 1882, which will come to be paid at the end of the year.
- "It will be seen that the item "Estimated Value of Stock of Journal (£185), has been replaced by an entry of the average Annual Sale of the Journal (£36 19s.), as representing the income to be expected from that source. The value of the Invested Stock of the Society appears also for the first time as an asset.
- "The final result shows an excess of assets over liabilities amounting to £111 14s. 4d.
- "At the York Meeting, an addition was made to the Rules, providing for the removal from the list of names those of Members three years in arrear. In accordance with that resolution four names have been struck off.
- "Death has also taken from us one corresponding member—Pastor Esmark, of Christiania, one ordinary member—Mr. J. Gilchrist Clark, and one associate—Mr. J. Maynard.
- "Resignations have been rather numerous, amounting to 6 among the members and 1 associate.
- "The elections, on the other hand, have more than made up for our losses, as they number 18 members and 1 associate, so that our total is slightly increased.
- "It is, however, evident that with little over 100 subscribing Members, the expenditure on the Journal requires careful supervision, and that the Council have been fully justified in continuing to restrict its issue, so as not to encumber the Society with debt.
- "The chief contributor to the Journal has been our late President, Dr. Heddle, whose magnificent Map of Sutherland was distributed in February, as part 21, while part 22, issued in May, contained a paper by him on Minerals new to Britain. The third portion of his Geognosy of

Sutherland appears in part 28, which will soon be placed in the hands of Members.

- "Part 22 contained also a most suggestive and interesting paper by Messrs. J. I'Anson and E. A. Pankhurst on the Structure of Agutes, which was beautifully illustrated with drawings by Mr. I'Anson, reproduced by the Autotype Process.
- "Two General Meetings have been held during the year, both in London, the first in December, 1881, the second in June, 1882, and the Council have under consideration the advisability of holding in future regular—say, Quarterly—Meetings at fixed dates."

GENERAL MEETING,

Professor A. H. Church exhibited a remarkable silicious concretion from the Upper Greensand of Haldon, Exeter. It closely resembles the menilite of Ménil Montaut, and Argenteuil, near Paris, but is not in reality a form of the liver opal occurring in those localities. A specimen similar to that shown gave on analysis the following percentages:—
