The fifty-first annual meeting of the Society was held on November 11-13, 1970 at the Sheraton-Schroeder Hotel and the Milwaukee Auditorium in Milwaukee, Wisconsin. The technical sessions were integrated as usual with those of the Geological Society of America and its affiliated societies.

The retiring President, William F. Bradley, addressed the Society on the morning of November 12th on the subject "The Low-Key Crystallography."

The annual business meeting of the Society was held on the morning of November 12, at which time reports were presented by the Secretary, Treasurer, and Editor of the American Mineralogist.

ACTIONS OF THE 1970 COUNCIL

The second and last meeting of the 1970 Council was held on Tuesday, November 10. The principal actions taken by the Council are summarized below:

Awards

The Council voted to award the Roebling Medal for 1971 to J. D. H. Donnay, and the Mineralogical Society of America Award for 1971 to R. A. Berner.

Fellowship

The Council approved the entire list of 13 members recommended for Fellowship by the Nominating Committee for Fellows. Their names will appear on the ballot submitted for approval by the Fellows in September 1971.

"Mineralogy Letters"

An *ad hoc* committee consisting of Subrata Ghose and Charles Prewitt has been exploring possibilities of initiating a new letter-type journal in the field of mineralogy under the auspices of The Mineralogical Society of America. The Council felt that a real need for such a publication has not been demonstrated, and that the Society could not endorse such an effort at the present time.

Amendment to the Constitution and By-Laws

The Constitutional amendments to provide equal rights and privileges for both members and fellows, as proposed by the Chayes committee, and partially rephrased with his concurrence, were accepted by the Council without editorial changes. They will appear on the ballots for the Society next Fall, but are available in the meantime on request from the Secretary. Petitions for the amendments with the required number of signatures had been received and circulated to Council members two months prior to the Council meeting, as is required by the present Constitution.

ACTIONS OF THE 1971 COUNCIL

The first meeting of the 1971 Council was held on Friday afternoon, November 13.

Budget

The budget presented by the Treasurer for 1971 was approved. The Executive Committee was instructed to review the financial situation of the Society periodically during the coming year, in consultation with the Financial Advisory Committee, and take appropriate action if serious financial difficulties arise.

Stock Transactions

The Treasurer was authorized to carry out business transactions (including buying and selling stocks, borrowing money) on behalf of the Society, until the time of the Annual Meeting in November, 1971.

Editor of The American Mineralogist

William T. Holser was unanimously reappointed for another term.

Committee and Other Appointive Officers

A list of appointive officers, prepared by the President in consultation with the Secretary and the Committee on Committees, was presented to the Council and with minor changes was unanimously approved. This list will be published in each issue of *The American Mineralogist*.

"Mineralogy Letters"

The Council confirmed the previous Council's conclusion that a real need for a new "Mineralogy Letters" publication has not been demonstrated.

Meeting for 1971

The regular sessions of the annual meeting of The Mineralogical Society of America will be held in conjunction with that of the Geological Society of America and affiliated societies in Washington, D. C., November 1-3, 1970.

REPORT OF THE TREASURER FOR 1970

The fiscal year ending July 31, 1970 closed with a deficit of \$6,248 of which \$3,349 was a net loss on selling some our investments. It should be noted that Society's financial records are maintained on a cash basis; therefore, premiums paid at the time of acquisition of the bonds were not amortized over the years during which the securities were held but had to be absorbed at the time of sale as a loss. The investments were sold to help pay for the publication of Special Paper Number Two. A second item that contributed to our deficit was a loss in revenue from page charges that were not honored after the authors agreed to the charges. Monies for these delinquent page charges are now being received after some prodding and these will be reflected in the next fiscal report. There appears to be a tendency during these times of tight money to delay in paying bills and this places hardships on the Treasurer's office. Again the Treasurer strongly urges that page charges be honored on time. It should be noted here that the page charge in our Journal—\$20.00 per page—is one of the lowest in any comparable journal. A nonrecurring expense that added to the deficit was our 50th Anniversary held at Atlantic City. About \$1400 was used above that which we received from registration and banquet levies. The money was used to help defray expenses such as travel and subsistence of our honored guests, special items concerned with the banquet, etc.

The Treasurer wishes to express his appreciation to all those who assisted him in the past year's activities which include those in the Finance Advisory Committee, Management Committee, Auditing Committee, 50th Anniversary Committee and the various staff members of AGI. Special thanks go to Mrs. Anne Irvin who is our manager at AGI for her patience with keeping all the details of the Treasurer's and the Secretary's offices separated.

FINANCIAL COMMITTEE OF THE REPORT FOR 1970

The Mineralogical Society of America ended its financial year on July 31, 1970 with a portfolio valued at \$217,335.37 which represents a decline of 15% in Capital Assets. Since the purpose of the endowment is income, the Financial Advisory Committee is pleased to report the income was \$10,927.03, an increase of 4.8% over the former year.

The table following shows the income from invested funds each year since 1970 and the cost and year end market value of the portfolio.

REPORT OF THE EDITOR FOR 1970

To the Council of the Mineralogical Society of America:

Publication operations in 1970 continued at the same pace as 1969, despite the relocation of the editorial office, and the extra load of Special Paper No. 3.

A report by Peter Fenner and Joel Lloyd (*Geotimes*, 15, no. 6, 14-17 (1970)) lists the serials of most importance to geologists, based on citations in the 1969 *Bibliography and Index of Geology*. Ninety four serials account for half of the citations. Of the fifteen of these that specialize within one or more of the fields covered by *The American Mineralogist*, we tie with *Geokhimiya* for the largest number of citations. This is consistent with another set of statistics published by A. O. Woodford (*J. Geol. Educ.* 17, 87-90 (1969)), which counts citations in seven geological journals published in the USA in 1967. He places *The American Mineralogist* as the first in its field, and third behind only the *Geological Society of American Bulletin* and the *Bulletin of the American Association of Petroleum Geologists* among all journals cited. These statistics, despite their obvious limitations, indicate the important position of our journal in both its specialized field and in geological science in general.

The new policy of accepting review papers, set by the council in 1969, was circulated to the Associate Editors and announced in the journal, and one proposal has been received.

PUBLICATIONS RESULTS

Volume 55 for 1970 totals 2193 pages, including 139 major articles and 57 notes. This exceeds slightly the previous high for 1968. Even so we end the year with a backlog of about half an issue. Details of the publication flow are shown in the following two tables,

with the intervals as defined in the report for 1969 (*Amer. Mineral.* 55, 631 (1970)). It should be explained further that the interval labelled *editing*, the time from median acceptance date until the manuscript issue is mailed to the printer, includes not only time of preparation for the printer and a built-in delay of 30 days equal to half the publication interval, but also any delay due to backlog.

Overall, the year has not seen any improvement in our publication schedules. The new office arrangements at Eugene will allow closer control over the editorial operation, which, I hope, will lead to an improvement in processing manuscripts.

SPECIAL PAPER NO. 3

Mainly due to the efforts of Benjamin A. Morgan and his Associate Editors, the three *Fiftieth Anniversary Symposia* were produced as the third in our series of *Special Papers*. Working on a tight schedule, authors, editors, and printers had the volume on the stands

by August. The timely appearance of this volume is a credit to the Society and to those who organized and participated in its celebration.

NEW EDITORIAL OFFICE

As a consequence of my new duties as Professor of Geology at the University of Oregon, the Editorial Office was moved to Eugene on September 1, 1970. For operations of *The American Mineralogist*, the University has provided Room 128 in the Volcanology Building, just down the hall from my own office and laboratory. Mrs. Helen Hollyer works half time as Editorial Assistant, and Mrs. Kathelen Davis half time as Secretary. The arrangement is considerably more convenient than it was in La Habra, where the editorial operation was a couple of miles from my office. The new situation should allow closer control over the operations, and at the same time free me of some details.

PLANS

A detailed study of the proposed larger format for the journal, authorized by the Council at its meeting in 1969, has not made any progress. The Banta Company had promised to present some proposals and costs, but they never came through, and at about the time that I should have been pushing them I was getting wound up to move.

ACKNOWLEDGEMENTS

This is an appropriate time to acknowledge the great contribution to the operation of this office that has been made over the last four years by Chevron Oil Field Research Company. Liberal management policies permitted delegation of a significant fraction of my working time to the job of Editor. They looked upon this as one way in which the Company could keep in the mainstream of scientific work, in the same way that they encouraged participation (not just attendance) in scientific meetings, and publication of research results.

The Associate Editors, Gabrielle Donnay, Richard C. Erd, Robert E. Newnham, W. Gary Ernst, Hugo Steinfink, and E-an Zen have expeditiously circulated manuscripts to referees, and in many cases done detailed criticism themselves. The following list of referees includes some that were inadvertently omitted in the list for 1969. Michael Fleischer and his IMA Committee provided abstracts of New Mineral Names.
