# Proceedings of the Fifty-Sixth Annual Meeting of the Mineralogical Society of America in Salt Lake City, Utah

The fifty-sixth annual meeting of the Society was held on October 20–22, 1975, at the Salt Palace and the Salt Lake Hilton in Salt Lake City, Utah. There were three technical sessions in mineralogy, four in petrology, and a symposium, "Minerals and Rocks Under High Pressure," arranged by Subrata Ghose. The sessions were integrated with those of the Geological Society of America and its other affiliated societies.

The retiring President, Arnulf Muan, addressed the Society on the morning of October 21st on the subject "Mineral equilibria in an interdisciplinary perspective." The annual luncheon of the Society was held in the Seasons North Room of the Salt Lake Hilton on October 21st. Roebling Medals were awarded to Michael Fleischer, who was introduced by F. Earl Ingerson, and to O. Frank Tuttle, who was introduced by Elburt F. Osborn. Unfortunately, Professor Tuttle's health did not permit him to be present at the luncheon. The Mineralogical Society of America Award was given to Roger G. Burns, who was introduced by William S. Fyfe.

The annual business meeting of the Society was held on the morning of October 21st in the Salt Palace. Reports were presented by the Secretary, the Treasurer, and the Editor of *The American Mineralogist*. The results of the election and the subject of the next Short Course were announced.

Prior to the meeting, a Short Course on Feldspar Mineralogy, organized by Paul H. Ribbe, was held at the Hotel Utah in Salt Lake City, October 17–19, with 95 people in attendance. The lecturers were Paul H. Ribbe, Joseph V. Smith, David B. Stewart, and Richard A. Yund. The lecture notes were incorporated into a paperbound volume, Feldspar Mineralogy, which was on sale at the Society's booth in the exhibit area. This volume and the previous year's volume on Sulfide Mineralogy are available from the Business Office at \$5.00 each.

#### Council actions

The second meeting of the 1975 Council was held on April 12, 1975, at the Business Office. The third

meeting was held on October 19 at the Tri-Arc Travelodge in Salt Lake City, Utah. The principal actions taken by the Council at these two meetings are summarized here.

#### Awards

The Council voted to award the Roebling Medal for 1976 to Carl W. Correns. The Mineralogical Society of America Award for 1976 will be given to Friedrich A. Seifert.

## Report of the Treasurer for 1975

This report covers the period January 1, 1975, through December 31, 1975, denoted FY 1975. During this period, accounting was done on the accrual basis, and the figures presented are therefore comparable with those for FY 1973 and FY 1974. They are not directly comparable with those for preceding years, when accounting was on a modified cash basis. The figures have been audited by Touche, Ross and Company, and, in their opinion, present a fair picture of the Society's financial position. A copy of the full audit report is on file at the Society's business office, at 1909 K Street, NW, Washington, D.C., 20006, and is available for inspection by any member who wishes to do so.

The financial data for the period covered are pre-

sented in Tables 1 (Combined Balance Sheet) and 2 (Statement of Income and Expense, FY 1975). Both tables are basically similar to those presented last year. The only substantive change in the Balance Sheet reflects transfer of our investment portfolio from Ruane, Cuniff and Stires to Stires and Company, Inc. The format of the Statement of Income and Expense is also basically similar to that of last year's report. Once again, the Society experienced a net gain on its operations. It should be noted, however, that the gain was due entirely to the extraordinarily strong performance of the Society's investment portfolio. Without this additional income, the Society would probably have incurred a small deficit. This income is, of course, extremely vulnerable to fluctuations in general economic conditions, and we cannot assume that income in this amount will continue to be available; accordingly, the M.S.A. Council has begun to consider options available to us if financial conditions should worsen.

I am particularly gratified to report the increase in activity of the Revolving Fund, due largely to the Society's program of Short Courses, and sales of Short Course Notes. This program is clearly financially sound, as well as scientifically valuable.

At present, the Society's financial condition appears sound, and we appear to be in a good position to weather whatever financial difficulties the next years may offer.

a) Expenses are divided into two categories: Direct Costs and Indirect Costs. Direct Costs are those incurred in direct support of a particular project and only in support of that project. Indirect Costs are those incurred in support of the various projects of the Society. Indirect Costs are allocated to the various projects on a basis proportional to their direct costs.

b) Dues and Contributions consist primarily of MSA dues to the American Geological Institute.

c) Office Expenses for The American Mineralogist are for printing and mailing labels to Byrd Press, billing for reprints and page charges, and handling orders for back issues.

### Report of the Financial Advisory Committee for 1975

During 1975 the market value of the Mineralogical Society of America investment portfolio increased 22.9 percent from \$261,249 to \$320,977 (Table 1), and thereby regained the loss suffered in 1974. The common stock portion of the portfolio was increased gradually during the year from 57.8 percent of the total on a cost basis at the start of the year to 77.3 percent at the end, and the market value of the common stocks increased from \$154,365 to \$235,686 during this period. Capital gains totalled \$54,189, primarily in MCA and in Moore McCormack Resources (Table 2). Dividends and interest amounted to \$25,204 (Table 3). The latter figure is larger than normal as a result of a \$6,000 special dividend received from Electronic Data Systems.

Mr. Sidney H. Stires, who served as MSA investment manager during 1973-75, has resigned in order to concentrate on the production of research reports. He has been replaced by Mr. William G. Campbell of New York City. This committee agrees with Mr. Campbell that it is in the best long term interests of the Society to take a more conservative approach to the market in the future so that our recent gains can be consolidated. We are concerned that the market valuation of Table 1, although representing the largest year-end total in MSA history, actually has declined considerably in the past six months and is now less than the cost value. We anticipate that Mr. Campbell will seek greater diversification than at present and will concentrate on the equities of companies that are well-established but

# Report of the Editor for 1975

Of the papers received by the Editor between August 15 of the prior year to August 14 of the calendar year, those accepted usually constitute *The American Mineralogist* of that calendar year. So computed, 151 (66.8%) of 226 manuscripts received were accepted and printed in 1973, 155 (78.7%) of 197 in 1974, and 152 (72.4%) of 210 in 1975. For the three-year period this becomes 458 (72.4%) of 633.

To stay within the number of pages budgeted by Council for the 1975 volume of *The American Mineralogist*, 7 completed papers, although ready, were withheld from the November-December issue and will be sent to press for the January-February 1976 issue instead. Two other papers, also ready for press, await resolution of questions of nomenclature by the IMA Commission. This backlog of nine papers or approximately one-third of an issue proved temporary because the influx of papers, rapid during July, abated somewhat during August and September.

As I retire as Editor, I wish to reiterate my indebtedness to the Boards of Associate Editors for 1972, 1973, 1974, and 1975. These include Arden L. Albee, Werner H. Baur, Arthur Boettcher, Charles W. Burnham, James R. Craig, Wayne A. Dollase, Jen Ho Fang, J. Jeffrey Fawcett, Joseph J. Finney, Donald M. Henderson, William D. Johns, Robert E. Newnham, Charles T. Prewitt, Paul H. Ribbe, Peter Robinson, Hugo Steinfink, Priestley Toulmin III,

Rosemary J. Vidale, David R. Waldbaum, and William B. White. Their hard and dedicated work resulted in important improvements and corrections to the papers submitted. They have helped us to maintain a high standard of quality.

Mary Holliman has served with great distinction and efficiency as Managing Editor. Her tendency toward orderliness admirably offset my own toward entropy. I thank my secretary, Vera Good, for cheerfully suffering (but not in silence) the increased work load and responsibilities that my term as Editor brought her. I am grateful to Wen Huang, Andrea Ross, and Carl Francis, who, with Mary Holliman, are bringing the 1966-1975 decennial index and the 1975 annual index to completion. I am pleased to thank several Councils of the Society for their unfailing support and rest secure in their selection of so eminent a scientist as Brian Mason to succeed me as Editor. Several Publications Committees of the Society—chaired by George W. Fisher, William C. Kelly, Gene C. Ulmer, E-an Zen—have also given unfailing support.

The quality of *The American Mineralogist* also depends on the conscientiousness of those who review papers at the request of the Editor or Associate Editors; their names are listed below.
